## CNG FUELING INSTRUCTIONS

### IMPORTANT:

- NEVER ATTEMPT TO FUEL A VEHICLE WHILE IT IS RUNNING!

1. Be sure all ignition sources are off.
2. Write down the mileage on the vehicle.
3. Select the appropriate pump.  
Does your vehicle require a 3600 psi fill or a 3000 psi fill? To determine which fill is appropriate, look behind fuel door of the vehicle you are attempting to fill.
4. Write down selected pump number next to your vehicle odometer reading. **NOTE:** Check **START/STOP** button (green button located above holder). Be sure the button is in the **"OFF"** position.

The **START/STOP** button has two positions - **ON** and **OFF**. When the button is indented, it is **ON**. When the button is flush it is **OFF**.

5. Remove nozzle from the pump you have selected. To do this, you will need to push the nozzle toward the dispenser while pulling yellow or blue coupler toward you; then pull nozzle away from dispenser.
6. Connect fueling nozzle to fuel receptacle on vehicle. To do this, remove plastic cover on vehicle fuel receptacle and firmly push nozzle until it locks into place. **NOTE:** pull on nozzle to make sure it is locked into place.
7. After connection is made, turn the valve on the fueling nozzle to the **ON** position. You will hear a small amount of fuel flow from the hose to the vehicle tank.
8. Proceed to the card reader with your hand-written information (pump number and mileage).
9. Insert card into reader and remove.


**NOTE:** be sure magnetic strip on card is in the upper left hand corner. If you get a message that states, **"PUMP OFF HOOK"** the pump **START/STOP** button is in the **ON** position. You must push the button to the **OFF** Position and repeat Step 9. If you attempt to insert card a second time without resetting the **START/STOP** button, you will shut down the system and you will be unable to get fuel.

10. The card reader will ask for the mileage of the vehicle. Input mileage on vehicle and press "Enter".  
The card reader will ask for pump selected. Input pump selected and press "Enter." Upon successful card read and all information is entered, the card reader will display **"BEGIN FUELING."**
11. Proceed to the fuel dispenser and push the **START** button. The button is the green button located above the nozzle holder. The button should be in indented position to start the pump. The dispenser will display all 8's momentarily and then begin the fill cycle.

Fuel flows briefly, then the system pauses for four seconds to measure the vehicle tank pressure. The dispenser automatically restarts the fill cycle and continues until the vehicle is about ¾ full. It then pauses again and takes a second to look at tank pressure; automatically restarts and fills to completion. On some systems, the valve may cycle more times, depending on system conditions at that particular time.

When the valve cycles, you will hear the valve open and close and see "StbY" in the lower right display window on the dispenser. When the filling process is complete, the dispenser alternately displays **"PUSH STOP."**

12. When the filling process is complete, push the **STOP** button on the dispenser. The **START** and **STOP** button on some dispensers, is the same green button. It should be in the flush position for **STOP**. Other dispensers have both a **START** and **STOP** button.
13. Return to the fueling nozzle and turn the valve on the nozzle to the **OFF** position.
14. Disconnect the nozzle from the vehicle the same way you removed it from the dispenser (see instruction #5).
15. Return the nozzle to the dispenser. Insert the nozzle into the nozzle holder the same way you connected to the vehicle receptacle (see instruction #6).
16. Replace the plastic cover on the vehicle receptacle.

## New York State Clean Fueled Vehicles Program

*New York State* is leading the way in the acquisition and use of clean fueled vehicles by its agencies, authorities, and universities. Governor Pataki has expressed his strong commitment to the use of clean fueled vehicles as part of the State's overall environmental conservation efforts.

*"The pursuit of clean air remains one of our greatest challenges. Last year, we gave New Yorkers the opportunity to buy the cleanest cars in the country... But we must not be complacent. We must set ambitious, long-term goals for the future. In 1995, New York State owned almost no clean-fueled vehicles. Today, almost 700 are on the road. This year, let's commit to ensuring that, by the end of this decade, every non-emergency vehicle purchased by State agencies—roughly 1,500 each year—are clean-fueled vehicles. This initiative will help attract more green businesses to New York, like the Baker-Ford partnership, which is creating 300 new jobs building electric vans, not in Michigan, but in the Mohawk Valley. We can make New York the national leader in clean air technology in this decade".*

Governor Pataki's Executive Order No. 111, issued June 10, 2001, positions New York State to become even more energy efficient and environmentally aware. Section 8, Alternative-Fuel Vehicles, of the [Executive Order No. 111 "Green and Clean" State Buildings and Vehicles Guidelines](#)  details AFV acquisition and annual reporting requirements for State entities. The guidelines were distributed to State agencies in December 2001. The New York State Clean Fueled Vehicles Program is a coordinated effort designed to help agencies, authorities, and State universities acquire and utilize clean fueled vehicles, and also satisfy federal requirements for purchasing such vehicles.
