- 7.) Appendix B-1 Section 76 – Amended Proof of License clause.
- 8.) Schedule 1 – Section 01 – Amended Best Pricing Offer language to coincide with Appendix B-1 Section 43.
- 9.) Schedule 2 – Section 01.3 – Amended Best Pricing Offer language to coincide with Appendix B-1 Section 43.

The 2nd Contract amendment sets forth the following item that represent a change from the original signed new CSA agreement.

Section 14 1st Paragraph Base Contract – The term (term) of this agreement shall be from November 1, 2005, through October 31, 2010, and shall be effective upon approval hereof by the Office of Attorney General (OAG) and OSC, unless otherwise terminated in accordance with the terms of the Agreement.
