<p>1. Personal Protective Equipment - Equipment worn to protect the individual from hazardous materials and contamination. Levels of protection vary and are divided into categories based on the degree of protection afforded. The following constitutes equipment intended for use in a chemical/biological threat environment.</p> <p>Level A: Fully encapsulated, liquid and vapor protective ensemble selected when the highest level of skin, respiratory, and eye protection is required. The following constitutes Level A equipment for consideration:</p> <p>1.1 Fully Encapsulated Liquid and Vapor Protection Ensemble, reusable or disposable (tested and certified against CB threats)</p> <p>add additional rows as needed.</p> <p>1.2 Fully Encapsulated Training Suits</p> <p>1.3 Closed-Circuit Rebreather (minimum 2-hour supply, preferred), or open-circuit Self-Contained Breathing Apparatus (SCBA) or, when appropriate, Air-Line System with 15-minute minimum escape SCBA</p> <p>1.4 Spare Cylinders/Bottles for rebreathers or SCBA and service/repair kits</p> <p>1.5 Chemical Resistant Gloves, including thermal, as appropriate to hazard</p> <p>1.6 Personal Cooling System, Vest or Full Suit with support equipment needed for maintaining body core temperature within acceptable limits</p> <p>1.7 Hardhat helmet</p> <p>1.8 Chemical/Biological Protective Undergarment</p> <p>1.9 Inner Gloves</p> <p>1.10 Approved Chemical Resistant Tape</p> <p>1.11 Chemical Resistant Boots, Steel or Fiberglass Toe and Shank</p> <p>1.12 Chemical Resistant Outer Boots</p> <p>Level B: Liquid splash resistant ensemble used with highest level of respiratory protection. The following constitute Level B equipment and should be considered for use:</p> <p>1B.1 Liquid Splash Resistant Chemical Clothing, encapsulated or non-encapsulated</p> <p>1B.2 Liquid Splash Resistant Hood</p> <p>1B.3 Closed-Circuit Rebreather (minimum 2-hour supply, preferred), open-circuit SCBA, or when appropriate, Air-Line System with 15-minute minimum escape SCBA</p> <p>1B.4 Spare Cylinders/Bottles for rebreathers or SCBA and service/repair kits</p> <p>1B.5 Chemical Resistant Gloves, including thermal, as appropriate to hazard</p> <p>1B.6 Personal Cooling System, Vest or Full Suit with support equipment needed for maintaining body core temperature within acceptable limits</p> <p>1B.7 Hardhat helmet</p> <p>1B.8 Chemical/Biological Protective Undergarment</p> <p>1B.9 Inner Gloves</p>
